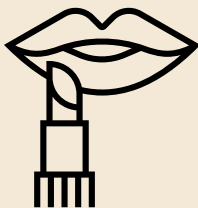

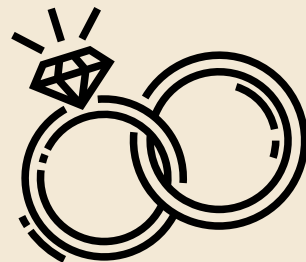

REFRESH

Full day (6hrs). This service commences once initial application is complete. Price does not include price of initial application. This service is applicable to anyone who has had their makeup done by Suzy Sela earlier in the day.

Starting @ \$1,500



Terms & Conditions

1. DEPOSITS

1.1 Deposit Requirement

A non-refundable deposit is required to secure all bookings.

- Bookings of 4 or more clients: 30% of the total service cost.
- Bookings of 3 or fewer clients: \$50.00 deposit.

1.2 Purpose of Deposit

Deposits secure the Artist's time and preparation. All deposits are strictly non-refundable and non-transferable, regardless of cancellation reason.

1.3 Balance of Payment

Remaining balances are due no later than 2 weeks prior to the appointment date. Unpaid balances may result in cancellation without refund.

2. BOOKINGS

2.1 Securing a Booking

Bookings are confirmed only once the required deposit has been received.

2.2 Conduct

Abusive or aggressive behavior will not be tolerated. The Artist may cancel services immediately without refund.

2.3 Agreement to Terms

By paying a deposit or signing this agreement, you acknowledge you have read and agreed to all Terms & Conditions and waive rights to refunds, chargebacks, or legal disputes over deposit policies.

3. PAYMENTS

3.1 Payment Method

Invoices will be sent electronically. Clients must send proof of deposit payment (e.g., screenshot).

3.2 Final Payment

Final payments must be received 2 weeks prior to service date.

4. TRAVEL FEES

Travel is available only for bookings of 4 or more clients.

Fee Structure:

- At Salon: \$0.00
- 0 km – 50 km: \$220
- 50+ km: +\$50 per additional 15 km
- Over 80 km: Hotel accommodation required the night before
- Start times before 6:30 AM: Hotel accommodation required

Additional Travel Expenses:

Client is responsible for airfare, parking, hotel, tolls, valet, and any travel-related costs.

The Client must provide:

- A suitable work table or surface
- Adequate lighting or power outlets
- A ground-floor setup when possible (due to heavy equipment)

Improper setups may affect service quality and are not grounds for refund.

6. DELAYS & PREPARATION

6.1 Timeliness

Clients must be ready with a clean, washed face.

6.2 Late Arrival

Arrivals later than 15 minutes may result in incomplete service; full payment will still apply.

6.3 Vendor Coordination

The Artist can coordinate timing with hairstylists or photographers with advance notice.

7. PHOTOGRAPHY, VIDEO & MEDIA RELEASE

7.1 Consent to Capture

The Client agrees the Artist may take photos or video footage during or after services.

7.2 Usage Rights

The Client grants the Artist a royalty-free, perpetual, worldwide, irrevocable license to use the media for:

- Portfolio
- Website & online galleries
- Social media
- Marketing & advertising
- Educational or training materials
- Published or promotional content

7.3 No Compensation

The Client will not receive payment, royalties, or rights for use of the images.

7.4 Working with Photographers/Videographers

The Artist may request images from third-party professionals and will credit them as appropriate.

7.5 Privacy Requests

Clients wishing for no photos or videos to be used must notify the Artist in writing prior to the appointment. Additional fees may apply for media restriction.

7.6 Group Bookings

The primary booking Client must inform other participants that images may be taken.

7.7 Editing & Representation

The Artist maintains full creative control over editing, cropping, and presentation.

7.8 Release of Liability

The Client waives all claims related to photo/video use including privacy, defamation, or copyright concerns.

7.9 Ownership

All media captured by the Artist is the Artist’s intellectual property and may not be altered or redistributed without consent.

8. CONFIDENTIALITY

Client information will remain confidential and will only be shared with necessary third parties (such as photographers or hairstylists) with the Client’s consent.

9. LIABILITY & ALLERGIES

All tools and products are sanitized between clients. Hypoallergenic products are used whenever possible.

Clients must disclose allergies or sensitivities before application.

The Client releases the Artist from liability related to allergic reactions or skin complications.

10. SERVICE PACKAGE INCLUDES

- Professional false lashes & application
- On-location services
- Travel (as agreed in invoice)
- Lip color for touch-ups
- Coordination of makeup schedule
- Additional services as detailed in final invoice

11. CANCELLATION & RESCHEDULING

11.1 Bookings of 4 or More Clients

Cancellations or rescheduling must occur at least 90 days before the appointment, or the full service amount will be owed.

11.2 Bookings of 3 or Fewer Clients

Cancellations or rescheduling must occur at least 12 days before the appointment, or the full service amount will be owed.

11.3 Deposit Policy

All deposits are strictly non-refundable.

12. CLIENT RESPONSIBILITIES

Clients must:

- Provide a safe, harassment-free environment
- Maintain open communication
- Provide a suitable service location

The Artist may terminate the contract immediately for safety concerns or policy breaches. Payments will remain non-refundable.

13. ACCEPTANCE OF TERMS

By paying a deposit, signing below, or booking services, the Client confirms they:

- Have read and understood the Terms & Conditions
- Agree to all policies
- Understand deposits are non-refundable
- Waive rights to disputes or refunds
